


### What's the Skinny Grandpa? - Virtual Reality Skin

In the medical sense, synthetic skin has been around since at least the 1970s; artificial skin is typically a collagen-based scaffold that induces regeneration of skin. Technology is advancing to the point where tissue can be lab grown so there will eventually be no need for dermis donors.

Medical advances aside, what if we told you that there are companies out there investing in building synthetic skin for other uses? A synthetic skin is being developed to add the sense of touch to videogames.

Initially developed by John Rodgers at Northwestern University in Illinois, the synthetic skin is

a patch that vibrates and pushes the skin's surface to simulate touch. The original use of this skin was to provide the simulation of touch for lost limbs to amputees.

You may have noticed that there were quite a few candidates who dropped out after early voting, but before Super Tuesday. This begs the question: what happens to your vote after a candidate drops out?

### What's the skinny Grandpa? - Virtual Reality



The same patch was also used to simulate strikes in a combat videogame. Leveraging the new knowledge of stretchable electronics and wireless power transfer, the patch of synthetic skin is thin, flexible, and able to work wirelessly, so it should be relatively easy for consumers to use once it is ready for release to the public.

The inventor is currently working on refining the touch sensations to add the ability to feel warmth and coolness in addition to touch. Rodgers is not alone in this venture. Imagine finally being able to pet that yellow electric type mouse or hug a family member 100s of miles away!

### It's a Trap or It's a Poll - Poll Predictions

Let's get back to the US presidential election, shall we? Usually around election time there are many articles containing predictions of the election outcome based on polled samples. Before we dive too far into this, it is first important to understand a sample and what it can mean for your results.

For example, you may have seen the following statistic published by major news networks "38% of beer drinking Americans say they won't order a Corona". Many of these articles claim that American beer drinkers are afraid or suspicious that there could be a link between the virus and the alcoholic beverage. But let's dig a bit deeper.

### It's a Trap or It's a Poll - Poll Predictions



The source of this statistic is from 5W Public Relations. While the original study has been removed from their site, you may notice that other food and drink related studies published by this company do not have meaningful statistics nor do these studies have a clear sample outlined. Which simply means they did not tell of how many people were in study or where the study was performed.

There is a huge difference between asking 100 people in person in Dresden, TN and pulling a sample of 1,000,000 people limited to US residents only via an online survey. The results will be dramatically different as the opinion of 1 person carries more weight within a group of 100, more than a group of 1,000,000. Something else to consider is that there is a sense of privacy when

someone answers an online survey versus giving a answer in person. Many people fear judgement and are more likely to answer honestly when given some level of privacy.

#### A Note about Poll Predictions

Now that we have covered samples, we can look at president poll predictions. Currently, there are not too many articles with presidential win predictions, and the lack of these articles may be due to the shock of the inaccuracy from the 2016 election.

This year, when the polls for the Presidential Election start to come out, ask yourself "What was the sample size?", "How was the data collected?", and "when was the data collected" before accepting what is reported to be the truth. Not all news is created equally.
